Green Eco Solutions warrants for all patio door products to the original owner/occupied single family residence in which these patio doors were originally installed. This warranty is subject to the conditions and limitations herein listed for as long as the original owner/purchaser resides in the home.

COVERAGE: This warranty provides to the original purchases of Green Eco Solutions that under normal operation, these patio doors will be free from defects in manufacturing and material for as long as you own and reside in the home. This warranty is transferable to the next property owner. Refer to section regarding warranty transfer.

WARRANTY

HARDWARE - LIFETIME

The Hardware is warranted against defects under normal use and service.

TIMBERX - LIFETIME

The TimberX components are warranted as long as you own and reside in your single family home against defects such as rot, pit, corrode, peel, or blisters provided that the recommended cleaning practices have been followed. Factory applied exterior and interior finishes are warranted for fifteen(15) years from date of original product purchase against peeling, blistering or flaking. Freight and installation shall be homeowners responsibility.

INSULATING GLASS UNIT- LIFETIME

The insulated glass is warranted against defects resulting in material obstruction of vision from film formation caused by the moisture in the airspace of the sealed unit. If condensation appears between the two pieces of glass Green Eco Solutions will furnish replacement glass without charge.

GLASS BREAKAGE WARRANTY

(Residential only) If the glass of the Green Eco Solutions Patio Doors purchased with the double strength glass breaks, the manufacturer will replace the glass component at no charge. This breakage warranty does not cover the following:

- Breakage caused by riot, civil disorder
- Building settlement or structural failures of walls or foundations
- Breakage due to acts of God and severe weather events



TRANSFER OF WARRANTY

TimberX, Glass seal failure and hardware portion of the warranty are transferable by the original residential homeowner to the next occupied owner of the property. Green Eco Solutions must receive the attached for within 60 days after official transfer of the property. Failure to submit written notice of transfer in 60 days will result in the termination of warranty coverage.
